
Spotlight on Que: Brother Stefon Atmore

Brother Atmore is a Christian, father, brother, and friend. He consistently displays the attributes of intelligence, inquisitiveness, modesty, resoluteness, empathy, and diplomacy. Atmore is also a leader and he fully understands the value of selfless service on behalf of people. His lengthy record of honorable projects and successes in the Masonic Order provides a model for others to follow within Omega and beyond. Brother Atmore's life is squared by the four cardinal principles of Manhood, Scholarship, Perseverance and Uplift; the fraternity's motto 'Friendship is essential to the soul' is his hallmark.

Brother Atmore and I met not long after his initiation into Omega Psi Phi. It was during the memorial service for the late Brother Samuel Hunter that I learned more about Brother Atmore and his talents and leadership. We have been linked ever since with mutual respect and exhortation. Atmore inquired on me and provided help during my wife's medical ordeal in 2019 for which I will



always be grateful. Brother Atmore's condensed story of family first, vocation, and fraternal pursuits are contained in the following paragraphs.

Brother Atmore was born in Babson Park, FL which has a population of 1300 people; there are no traffic signals just a caution light. Atmore's family moved to Lake Wales, FL (7 miles away) where he attended and graduated from Lake Wales Senior High School. In school, Atmore was a letterman in both football (receiver & amp; defensive back) and track (120 & amp; 330 hurdles, 4x100, long jump and triple jump); he was in ROTC and participated with the drill team. Brother Atmore's parents are deceased and he has three sisters, Ellen and Eunice both of Lake Wales, FL and Sharon who is deceased. Atmore has three adult children, two of which are twins: Stefon Jr. (age 33); Ashton (age 27, enrolled in medical school at the University of North Carolina; and, Yazmin (age 27, an artist with a degree from Metro State University). Brother Atmore delights in spending time with his children, playing racquetball, golf, and socializing.

Brother Atmore graduated with a Bachelor of Science degree in Occupational Education from Wayland Baptist University in October 1999. He obtained his first Master of Science degree in Human Resources Administration from Central Michigan University in May 2001 and a second Master's degree in Health Administration from Webster University in May 2010. Atmore started a PhD program in Business Administration.

Brother Atmore currently works as a Senior Veterans Service Representative (authorizer) at the Denver Veterans Administration Regional Office, Veterans Benefits Administration. He promulgates and authorizes disability claims for veterans. Atmore serves as a mentor to team members and new employees assigned to the Post Development Team. He started with the Veterans Administration (VA) as the Lead Medical Instrument Technician (hemodialysis) at the Denver Veterans Administration Medical Center (VAMC). Brother Atmore volunteered as an employee of the Denver VAMC to help with the aftermath of two tragic hurricanes, Katrina and Rita. He travelled to Marlin, TX and Waco, TX, taking care of displaced people from New Orleans, LA and Houston, TX affected by the two devastating storms. He has worked 10 years each at the Veterans Benefits Administration and the Denver VAMC. Brother Atmore has received two VA employee awards.

Brother Atmore is a retired Staff Sergeant from the United States Army, having served honorably from August 1981 to August 2001 for a total of 20 years and 17 days. He was stationed in Gelnhausen, Germany as a combat medic with the Headquarters and Headquarters Company (HHC), 1st Battalion, 48th Infantry, 3rd Armor Division. Atmore was assigned to Fort Carson, Colorado Springs, CO, with the HHC, 4th Infantry Division. He attended and completed the Army's Practical Nurse Program (License Practical Nurse - LPN) at Fitzsimons Army Medical Center (AMC), Aurora, CO. Atmore was the non-commissioned officer in charge (NCOIC) of the Surgical Clinic at Eisenhower AMC, Augusta, GA prior to attending the Army's Hemodialysis

program at Walter Reed AMC, Washington, D.C. Atmore returned to Fitzsimons AMC serving as a LPN and hemodialysis technician. He became the NCOIC of the dialysis technicians at Tripler Army Medical Center, Honolulu, HI; the Hemodialysis unit covered the Pacific Rim Region.

- Feeding the less fortunate.
- Developed a widow's program in 2003 for his Masonic lodge providing bi-weekly checks on their well-being and ascertaining any type of assistance or need; widows are treated to lunch or dinner once a quarter to show that the lodge still cares.
- Participated with the Thanksgiving and Christmas baskets and Toys for Tots program at the Masonic lodge.
- Served as treasurer and board member for the Colorado Ravens youth basketball group, 2004 -2007. The Colorado Ravens is a non-profit youth organization based in Denver/Aurora. Most of the youth are from low-income, single-parent households; they are encouraged to participate in the basketball, golf, and educational programs. The Colorado Ravens youth organization is designed to provide guidance and mentorship to disadvantaged children.
